CHILDREN'S HOME SOCIETY HAS BEEN SERVING CHILDREN AND FAMILIES FOR MORE THAN A CENTURY, WITH PROGRAMS BUILT ON OUR MISSION OF PROMOTING THE RIGHT OF EVERY CHILD TO A PERMANENT, SAFE, AND LOVING FAMILY. FOUNDED IN 1902, CHS HAS PLACED MORE THAN 14,500 CHILDREN INTO LOVING, ADOPTIVE HOMES. BUT WHILE CHS IS PERHAPS BEST KNOWN FOR OUR WORK RELATED TO FOSTER CARE AND ADOPTION, WE ARE MUCH MORE THAN A PLACEMENT AGENCY. MERGERS WITH FAMILY LIFE COUNCIL, YOUTH HOMES, AND LIFEGAINS HAVE GREATLY EXPANDED THE SCOPE OF SERVICES WE ARE ABLE TO PROVIDE TO NORTH CAROLINA'S CHILDREN AND FAMILIES. TODAY, CHS HAS ONE OF THE MOST COMPREHENSIVE AND SEAMLESS OFFERINGS OF CHILD WELFARE AND FAMILY SUPPORT SERVICES IN THE STATE - PROVIDING PROGRAMS IN PARENTING EDUCATION, FAMILY PRESERVATION, TEEN PREGNANCY PREVENTION, FOSTER CARE, AND ADOPTION - ALL FROM ONE AGENCY. SPECIFIC CHS INITIATIVES INCLUDE WORKING TO PREVENT TEEN PREGNANCY, PROVIDING EDUCATION AND SUPPORT FOR PARENTS HAVING DIFFICULTY MAINTAINING A STABLE FAMILY SETTING FOR THEIR CHILDREN, AND SUPPORTING THE EFFORTS OF PUBLIC SOCIAL SERVICES AGENCIES TO PRESERVE FAMILIES. WHEN A CHILD'S BIRTH PARENTS ARE UNABLE TO PROVIDE A SAFE, POSITIVE FAMILY ENVIRONMENT, CHS FINDS SAFE SHELTER FOR THOSE CHILDREN THROUGH FOSTER CARE AND ADOPTION. ACCOMPLISHMENTS FOR THE FY'12 INCLUDE BIRTH PARENT SERVICES, PRENATAL AID IN DECISION-MAKING, MEDICAL CARE, LIVING ARRANGEMENTS AND OTHER PREGNANCY-RELATED SERVICES WERE PROVIDED TO 87 CLIENTS. FOSTER CARE SERVICES: TEMPORARY FOSTER CARE FOR CHILDREN, INCLUDING 24-HOUR NURSING SUPPORT, WAS PROVIDED TO 503 CLIENTS. ADOPTION SERVICES: RECRUITMENT OF ADOPTIVE PARENTS, PRE-PLACEMENT ASSESSMENTS, TRAINING AND PREPARATION OF FAMILIES WANTING TO ADOPT CHILDREN WITH SPECIAL NEEDS, AND RELATED ADOPTION SERVICES AND COUNSELING WERE PROVIDED TO 1,928 CLIENTS. FAMILY FINDING SERVICES: SERVICES TO IDENTIFY AND RECONNECT YOUTH IN FOSTER CARE WITH BIOLOGICAL FAMILY MEMBERS AND OTHER IMPORTANT ADULT INFLUENCES WERE PROVIDED TO 367 YOUTH. IN-HOME SERVICES: FAMILY PRESERVATION AND RIGHT START PROGRAMS FOR IMPROVING FAMILY FUNCTIONING USING STANDARDIZED PRE-POST ASSESSMENT TOOLS. PROGRAMS ARE FOCUSED ON KEEPING CHILDREN IN THEIR OWN HOMES. THESE PROGRAMS SERVED 291 FAMILIES AND 684 YOUTH. EDUCATIONAL SERVICES: EDUCATION SERVICES PROVIDED TO ADULTS AND TEENS TO FOSTER HEALTHY DECISION MAKING AND RESPONSIBLE ACTIONS AND CHOICES. THESE PROGRAMS SERVED 7,321 YOUTH AND 5,185 ADULTS.
