GOD'S WORLD PUBLICATIONS, INC. (GWP) PROVIDED NEWS MEDIA FOR CHRISTIANS OF ALL AGES AND IN A VARIETY OF CHURCH AND EDUCATIONAL SETTINGS DURING FISCAL YEAR 2013. GWP CONTINUED ITS TWO MAJOR PUBLISHING PROGRAMS FROM PRIOR AREAS. OVER 100,000 FAMILIES PER ISSUE BENEFITED FROM RECEIVING WORLD MAGAZINE, GWP'S BI-WEEKLY NEWS MAGAZINE TARGETED TO ADULTS, AND OVER 100,000 KIDS -- FROM PRE-SCHOOL THROUGH HIGH-SCHOOL -- INCREASED THEIR KNOWLEDGE OF THE WORLD AROUND THEM THROUGH READING GWP'S GOD'S WORLD NEWS MAGAZINES. THESE ACCOMPLISHMENTS FROM OUR PUBLISHING PROGRAMS WERE ACHIEVED DESPITE THE INCREASINGLY UNFAVORABLE ECONOMICS OF PUBLISHING. PAPER COST AND POSTAGE INCREASES, ALONG WITH COMPETITION FROM INTERNET AND OTHER ELECTRONIC MEDIA, HAVE SLAMMED THE PUBLISHING INDUSTRY. CERTAINLY NON-PROFIT ORGANIZATIONS LIKE GWP HAVE FELT TREMENDOUS FINANCIAL PRESSURE RESULTING FROM THESE TRENDS, AND TO CONTINUE THE ACCOMPLISHMENT OF OUR PROGRAM OBJECTIVES, GWP STEPPED UP ITS EFFORTS TO PROVIDE CONTENT THROUGH THE INTERNET AND OTHER ELECTRONIC FORMATS. WITH LIMITED RESOURCES, WE MADE IMPROVEMENTS TO OUR WEBSITES, DEVELOPED DIGITAL APPS, AND ROLLED OUR NEW WEBSTER CONTENT TARGETED TO NEW AUDIENCES. OUR JOURNALISM TRAINING PROGRAM, WORLD JOURNALISM INSTITUTE (WJI), HAS ALSO SHIFTED ITS FOCUS FROM TRADITIONAL PRINT MEDIA TO "NEW MEDIA" JOURNALISM. WJI CONTINUED TRAINING ASPIRING JOURNALISTS IN RESIDENTIAL CLASSES DURING FISCAL YEAR 2013. OF SPECIAL NOTE IS WJI'S OUTREACH TO MINORITY JOURNALISTS, PARTICULARLY AFRICAN-AMERICAN AND HISPANIC JOURNALISTS, IN A SERIES OF CONFERENCES THAT ADDRESSED ISSUES OF MINORITY JOURNALISTS OF FAITH.
