Quality Early Care and Education - Based on research showing the long-term impact of early education, the Partnership focuses on strategies that improve the quality of child care, increase access to child care for low income families and support early childhood teacher education. The Partnership also offers NC Pre-K (formerly More at Four), a quality pre-kindergarten classroom program for 420 at risk four year old. The Partnership manages a federal grant to provide full comprehensive Early Head Start services to 100 infants and toddlers (0-3) via two modalities: Center-based and Home-based services.

Health, Early Intervention and Family Support - Physical and developmental health is critical to a child being in the best condition to learn. In response to this need, Durham's Partnership for Children invests in a variety of programs that offer support for parents and child health and developmental interventions. The Partnership funds a continuum of Family Support programming in Durham County including linking families to community resources, hospital visits to new parents, curriculum-based parent education and literacy series and intensive home visiting program.

4c (Code: CDCB) (Expenses \$ 465,188 including grants of \$ 14,310) (Revenue \$)

Community Development and Capacity Building - The Partnership funds two strategies, Community Awareness and Education and Program Coordination and Evaluation, which focus on Community Development and Capacity Building. The Community Awareness and Education program creates educational materials, develops, manages, and supports public relations activities; delivers workshops; and coordinates events in order to build awareness of issues affecting young children and their families. The Program Coordination and Evaluation program conducts technical assistance, monitoring, evaluation, program development, and needs assessments in order to achieve program excellence and effectiveness in early care and education, health and early intervention and family support services. Three community based initiatives also fall under Program Coordination. Durham Touchpoints Collaborative (new - see Part III 2 above), Transition to Kindergarten, and the Faith Initiative.

Monitoring tools developed by the NC Division of Child Development must also be used at the local level for self-review and verification of compliance with the operating requirements. The NC Division of Child Development conducts on-site monitoring annually at the local contractor's site. Early Head Start Monitoring: The Partnership in compliance with Federal standards and administrative requirements provides ongoing monitoring of its operations as well as those of its contracted delegate agency. It is the policy of the Grantee that all programmatic, fiscal, and management areas of the Early Head Start program are regularly reviewed and that appropriate and timely follow-up is provided to ensure correction of non compliance issues. A full monitoring review of the delegate agency is conducted by program and fiscal staff on an annual basis to assess compliance with performance standards and contract requirements. A monitoring tool has been developed using the Office of Head Start Monitoring Protocol and Self-Assessment Booklets. Monitoring includes a review of compliance with Head Start Performance Standards and compliance with the development and implementation of the financial management system. This will involve a detailed review of the financial reporting accounting records, internal controls, and budget controls. The Partnership staff reviews program and fiscal data including financial status reports, financial source documentation for expenditures, monthly program updates, Head Start Enterprise System (HSES) reports, ChildPlus reports, year-end report and Performance Information Review (PIR) information. A monitoring report, including scope of testing, any issues noted, and recommendations will be provided to the delegate agency.

Background about the Partnership

Since 1995, Durham's Partnership for Children (the Partnership) has created a comprehensive early childhood system that supports collaborative service delivery and planning for young children birth to five. Durham's Partnership for Children has formed strategic alliances with government, business, medical, faith, and education sectors to integrate services based on evidence-based practices and measurable results.

Durham's Partnership for Children, one of 76 local Partnerships in North Carolina, is the community leader charged with implementing North Carolina's Smart Start Initiative and NC Pre-Kindergarten Program for Durham County. Our mission is that every child in Durham will be healthy and ready for school. In FY 2012-13, 11 Smart Start funded programs, 34 NC Pre-K classrooms, and Early Head Start with child care and home visiting components provided services to improve children's development in the five domains of school readiness. Durham's Early Childhood System Framework and the Partnership's Strategic Plan emphasize strengthening and building awareness for high quality early care and education, expanding the reach and impact of family support programming, supporting access to health services and early intervention, and ultimately promoting economic development in Durham County.
