Annually, the Foundation awards scholarships to individuals who are pursuing careers in professional counseling, and who commit to serving those in military and/or rural communities for 2 years post graduation. To date, the NBCC Foundation has provided scholarships to counseling students committed to serving rural and military communities in 17 states.

4b (Code) (Expenses \$ 10,000. including grants of \$ 10,000.) (Revenue \$ 0.)

The Foundation supports efforts to build the capacity of communities to provide mental health care through implementation of the NBCC Mental Health Facilitator program. To date, the NBCC Foundation has supported the implementation of the Mental Health Facilitator program in several countries, and ongoing to support to the programs in Bhutan, Malawi, Malaysia and Mexico; and has provided counseling education materials free of charge to Cambodia, Malawi, Nigeria, Portugal, and Romania.

The Foundation provides administrative expertise for the NBCC Minority Fellowship Program, through which twenty-four doctoral students in counseling received \$20,000 education awards, training assistance, mentors and networking opportunities to enable them to successfully complete their programs, and take leadership roles in reducing the disparities in mental health care for minority populations.

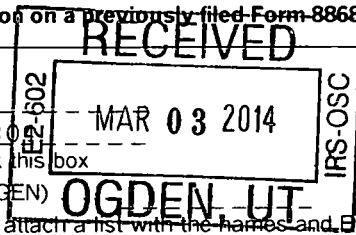
