	The Foundation processed in excess of 17,000 gifts from over 17,000 donors during the course of the fiscal year. Foundation development staff completed over 1,600 phone calls and 1,800 personal visits to major gift donors during fiscal year 2013. These calls and visits were in addition to the numerous contacts completed during the cultivation and other events held on and off of the University of North Carolina at Chapel Hill campus. The Foundation has an established recognition society that recognizes and cultivates donors who provide annual support of at least \$2,000. Members of this society receive recognition in the annual report and on the Foundation's donor wall. Endowment donors receive annual financial reports on the performance of the endowments they established and the use of the annual distributions. The Medical Loyalty Fund produces an Early Case Statement, which includes a review of annual fundraising results. The Medical Foundation manages over 1,800 funds, including endowments, restricted, and unrestricted funds. These funds provide key support for patients, students, faculty, research, and other School of Medicine priorities. The support these funds provide is essential to the continued instructional and research excellence of the School of Medicine and UNC HealthCare System.
