Manage housing for low to moderate income families.
The primary purpose of CHAD (Columbia Housing Authority Developments, Inc.) is to supplement the development of quality affordable housing for CHA (Columbia Housing Authority of the City of Columbia, SC). CHA's primary goal is to provide quality, affordable to low-income residents of Richland County by effectively managing the public housing inventory and increase the number of affordable housing units. CHA also strives to improve the quality of life for these residents and other low-income residents of Richland County. This may include career development and job training programs, family self-sufficiency efforts, as well as economic development, such as our commercial center at the Celia Saxon Homes. CHAD is frequently the instrument used to create these programs outside the traditional Department of Housing and Urban Development funding. CHAD has added to community to provide single family dwelling housing through the purchase of Capital Heights and Bayberry Mew in the prior fiscal year. These most recent purchases have increased single family dwelling housing for 200 low income families in Richland County.

The commercial center developed in connection with CHA's HOPE VI project contains space for a grocery store to provide easy access for residents, including seniors. The grocery store is now vacant, but the remaining units are occupied by a credit union, a tax service, a health care division of the city and by a Grant division of CHA. CHAD is still pursuing a grocery tenant for the vacancy.

CHA provides support to CHAD through a transfer of revenues from their Central Office Cost Center to supplement the Commercial Shopping Center site that has suffered from the grocery store vacancy.
