GateKey Scholarship Program - Establishes two-year scholarships for eligible, high-risk students giving them the opportunity to work toward an attainable goal of a college education. GateKey provides funds for tuition, fees, and a book allowance with the option to attend either Georgia Highlands College or Chattahoochee Technical College. Students may be nominated for a GateKey Scholarship in grades 6 through 11. If selected, students must maintain at least a "C" average in all classes, complete all school work, and remain crime and drug free. The program currently support 74 students.

Least of These/Student Support - Provides assistance to students identified as homeless or at-risk. Assists with needs that cannot be covered with other school system federal grant funds for homeless students. Assists in leveling the playing field between socio-economic groups so that students have ability to be involved in school activities and have items necessary to make them academically successful.
