We partnered with Miami Dade County Extension Services, 4-H, University of Florida, USDA, Florida Department of Agriculture and local growers. The Ag Venture provided an opportunity to showcase South Florida agriculture with a farmer's market and locally grown produce from South Dade High Students FFA. There were over 40,000 attendees for the 3-day event held at Tropical Park, FL.
