Teaching Tools for Hillsborough Schools provides critical school supplies year-round to economically disadvantaged students The program allows teachers from Title I schools the opportunity to shop for free school supplies to distribute to their students in need Teaching Tools serves 130 Title I schools and reaches more than 60,000 at-risk students annually Since 2002, we have distributed more than \$13.1 million in free school supplies to our schools in Hillsborough County The Teaching Tools Store is a real brick and mortar store stocked 100 percent through donations from individuals and local businesses, purchases with donated funds and partnerships with organizations

When learning is fun, learning is easy Through School Enrichment Grants we provide funding for teachers with bright ways to enhance the learning environment and inspire their students through innovation and excitement Working with our corporate and community partners, we were able to provide over 150 grants to help fund projects that go beyond the typical school budget for classroom enhancement Sometimes, all a student really needs to succeed is someone to believe in them Now in its 4th year, the AmeriCorps Graduation Pathways program is helping students in grades K-12 who are at-risk of dropping out of school in Hillsborough and Leto High Schools and 21 feeder elementary and middle schools Our 23 dedicated AmeriCorps members mentor over 260 students each week They help them not only through encouragement and assistance with school work, but also through teaching invaluable lessons of goal setting, personal values, fostering academic goals and exploring career path options Last year, 86% of these students were promoted to the next grade level and 100% of our mentored seniors graduated from high school

Success for so many high school students lies in scholarships to college At the Hillsborough Education Foundation, it is our number one priority to help ensure those students who are motivated and able to go to college have the financial resources to do so Together with community partners and through events like our Strides for Education 5K Walk/Run, we were able to award scholarships to more than 400 students last year The Foundation works in collaboration with the statewide Take Stock in Children program to offer scholarships to low income students between the 6th and 10th grades These students can receive a two-year community college, four-year state college or four-year university Florida prepaid scholarship In this program, we also pair mentors with low-income 6th through 10th graders to help these students get the support, motivation and accountability they need to escape the cycle of poverty, graduate high school and attend college on a scholarship Last year, we provided over 30,000 mentoring hours to 367 students, delivered by 279 dedicated volunteer mentors We also provide cash scholarships starting at \$1,000 to juniors and seniors who meet minimum requirements including GPA, income, community service and school involvement

We believe that the best teachers result in better student outcomes It's been proven that Board Certified teachers foster achievement in the classroom National Board Certified Teachers (NBCT) meet rigorous standards of excellence that far exceed the basic requirements of state teacher licensing NBCT grants are a new initiative launched by the Foundation in 2012 to provide \$500 matching grants to help teachers in achieving certification The Foundation believes that outstanding teachers and support staff should be recognized for their achievements Each year we collaborate with the Hillsborough County Public School District for the annual Excellence in Education Awards to recognize faculty and staff who consistently bring forth extraordinary efforts to make miracles happen for our students and schools At this event, over 3,000 educators and members of the community honor the Teacher of the Year, the Ida S. Baker Diversity Educator of the Year and the Instructional Support Employee of the Year In 2013, the Foundation launched its Teaching Excellence Lecture Series designed to engage educators, administrators, parents and policy makers in leading-edge education trends and topics that impact the classroom This new initiative will help teachers continue to be the very best educators they can be, which in turn brings out the best in our students

Half of the fastest growing occupations in Florida require some training beyond high school, but not a college degree By supporting Hillsborough County's 4 Career Centers, we are helping to prepare students to become the next generation of American workers We provide financial assistance to help students focused on CTE training in an effort to help them graduate and cement better career opportunities beyond high school Career and technical scholarships and financial assistance through Project Success come from a triad of support by the Foundation, Hillsborough County Public Schools and the business community

However, they may be present to provide clarifying information in such a discussion or debate unless objected to by any present board or committee member. A copy of this policy shall be given to all Board members, staff members, or volunteers, upon commencement of such person's relationship with the organization, or at the official adoption of stated policy.
	Form 990, Part VI, Section B, line 15	Key Officer - President In order to insure that the president's compensation is fair and reasonable, the Foundation's Board established an independent Compensation Committee made up of its members to review and determine the president's compensation package on an annual basis. The Compensation Committee, chaired by the Chairman of the Board, sets written yearly goals that are measurable. Near the president's anniversary date, the Compensation Committee reviews the goals and the written results to decide his compensation package and salary increases. As an aid in this process, the Compensation Review Committee reviews salary surveys and comparable data obtained from reliable outside sources. Compensation is reviewed and approved based on performance. There is contemporaneous documentation and record keeping with respect to the deliberations and decisions regarding compensation arrangements. After a decision has been made, a letter is written to the Vice President of Finance and Administration authorizing the President's compensation package for the coming year and is approved by signature by the Chairman of the Board. Other Officers & Key Employees Once a year at the direction of the President, other officers and key employees set written goals. These goals are reviewed and a written performance evaluation is prepared for each key employee by the President. Third party salary surveys and comparable data also aid in determining their compensation. All raises are based on merit. Key employees on a personal improvement plan or during their 90 day probationary period are not eligible for a raise. Raises are fully discretionary and under certain circumstances, including lack of sufficient funding, may not be awarded. Other Staff Written performance evaluations of other staff are completed annually. Other staff also set written goals each year and the results of these goals, along with their performance evaluations, are used when considering staff raises. Salary adjustments for promotions will also be considered based on comparative data and level of responsibility. All raises are based on merit. Employees on a personal improvement plan or during their 90 day probationary period are not eligible for a raise. Raises are fully discretionary and under certain circumstances, including lack of sufficient funding, may not be awarded.
