Monthly reimbursement requests are thoroughly reviewed by the Director
of Finance & Administration prior to being approved for payment. IN
addition, random audits of monthly expenditure reports are conducted for
all subrecipients, once or twice per contract year. In an audit month, all
support documentation must be submitted for review by a contracted CPA
consultant (Healthy Start) or by the Ounce of Prevention/Healthy Families
Florida Fiscal Staff (Healthy Families).
