The document failures which are the subject of this Statement occurred with respect to the Deferred Compensation Agreement ("Agreement") entered into between Kentucky Thoroughbred Association, Inc. (the "service recipient") and David L. Switzer (the "service provider"). The document failures are eligible for correction under the terms of Notice 2010-6, specifically sections VI.A, VII.D and VII.E. More particularly, the original provisions of the Agreement provided that payment to the service provider was to commence "not later than six months" following the payment event (Notice Section VI.A) and was to be paid in installments over "a period not to exceed ten years" (Notice Section VII.D). In addition, the service recipient in its discretion could accelerate payment "to meet situations of financial hardship, emergency or necessity" (Notice Section VII.E).

As of June 30, 2013 (the last day of the service recipient's taxable year), the service recipient has taken the action necessary to correct the three above-described document failures through its adoption and execution on January 24, 2013 of an amendment to the Agreement. The amendment, which was effective upon its execution, (1) replaces the six-month payment commencement period with a 90-day period with respect to which the service provider does not have a right to designate the taxable year of payment (Notice Section VI.A); (2) removes the discretion as to the length of the payment period by changing the installment payment period from "over a period not to exceed ten years" to "a period of ten years" (Notice Section VII.D); and (3) permits a payment to be accelerated at the service recipient's discretion only upon the occurrence of an unforeseeable emergency, which is defined in the amendment in accordance with the provisions of Reg. §1.409A-3(i)(3) (Notice Section VII.E).

It is not anticipated that a payment event will occur for purposes of the Agreement prior to January 25, 2014 (the date which is one year and one day following the date of correction).

The amount involved as of June 30, 2013 for the three document failures described above is \$136,737.37. It is not necessary for the service recipient to report any amount as includable income under Code Section 409(A)(a) as part of the correction.
