Provided funding for endowments held by The Idaho Community Foundation and The Inland Northwest Community Foundation for perpetual funding of our operating grants for the Lake Pend Oreille School District. It is an example of our long term commitment to our mission.

4b (Code) (Expenses \$ **48,349** including grants of \$) (Revenue \$)

Funded the READY! for Kindergarten program, an early childhood literacy program created for families with children ages birth to five years old. READY classes give parents the tools and information they need to prepare their children for starting school at age 5. National average indicates 44% of children entering kindergarten test below "readiness proficiency" and these children stay behind resulting in low self esteem, anger and withdrawing. These problems can be overcome by having them ready for school before they start kindergarten.

4c (Code) (Expenses \$ **161,301** including grants of \$ **88,223**) (Revenue \$)

PAFE's Teacher Grants are awarded on an annual basis to teachers who compete for available funds. Awards are based on innovation, collaboration, impact on education, and a cost benefit analysis. Examples include classroom technology, lab/safety equipment, musical instruments, robotics, math and book clubs, and more. The CORE Reading Program is a universal re-training for all teachers, K-12, on state-of-the-art reading methodology. Funded a career/college guidance counselor and center covering college application process, SAT and ACT testing, and financial aid. Funded a professional District Volunteer Coordinator to identify key roles for community members with special talent and available time.
