Middle Tennessee Medical Center Foundation provided a \$2 million grant to Saint Thomas Rutherford Hospital ("STRH") (f/k/a Middle Tennessee Medical Center, Inc.) for the purchase of the new facility. In addition, the Foundation awarded to STRH a \$33,144 grant to STRH for bioterrorism emergency preparedness equipment, \$36,000 operating expense reimbursement for the Dispensary of Hope, \$1,744 mobile health unit expense reimbursement, \$20,252 in conference and education expense reimbursements, \$4,750 for associate nursing scholarships, \$28,696 for the purchase of patient and family shuttles, and \$395,000 for the purchase of a new Cath Lab

Foundation provided grants to help with indigent families' expenses as well as grants to pay for indigent patient mammograms (approximately 602 mammograms, \$140 each). Foundation provided \$2,211 to patients needing Lymphedema compression garments for treatment

Provided assistance to 104 employees assisting with food cost, rent/mortgage payments, utility payments, car repairs, legal fees, insurance expense, property taxes, etc. Educational grants were provided to 15 STRH associates and 3 nursing scholarships were also granted to STRH associates. In total, 122 STRH associates were granted assistance from the Foundation
