PUERTO RICO PUBLIC HOUSING ADMINISTRATION (PROJECT LEARN PROGRAM):
Project Learn is a comprehensive program that impacted more than 2,800 bona fide residents from the different housing projects within the ages 6 through 18, and 2,225 adults through its Family Support program. Participants took part in a fun and secure environment to develop their full potential as productive individuals. Programs supported included Power Learning (831 participants), Drug Prevention (708 participants); Leadership Program (244 participants); Performing Arts (615 participants); Sports and Recreation (1,729 participants); and Family Support (2,427 participants). All participants were exposed to educational forums, prevention programs, family support systems, community development programs, sports and recreation programs, and micro companies development. For fiscal year 2012-2013, 100% of the work plan presented to PRPHA was accomplished. Major program results were as follows. 95% of participants pass grade, 97% of participants graduated from high school, and 95% of participants will continue with college education. In the drug prevention area, 80% of participants abstained of drinking, 94% abstained to use tobacco and 92% abstained from using marihuana and other drugs. Participants increase their knowledge in relation to sexuality and consequences of sexual relations at an early age, accordingly; 67% of teens abstained to be sexually active.

21st CENTURY COMMUNITY LEARNING CENTERS:
21st CCLC is a program which main objective is to improve academic progress, as well as technology skills of participants. During fiscal year 2012-2013, 1,411 participants between the ages 6 and 18, and 385 parents benefited from the program. At least 90% of participants attended services for 30 days or more. Program results statistics were as follows:
 * 271 participants concluded their school year with an A grade average ; and 348 participants did it with a B grade average
 * 140 out of 458 participants (31%) that started the program with C, D or F grades, ended the school year with A or B average
 * All participants took part in sport and recreational activities as well as art programs
 * Parents of participants took part of educational forums and employment opportunities forums, family time management, and healthy lifestyles.

TANF - SMART MOVES:
TANF Smart Moves is a prevention services program through the Smart Moves module. Services provided included education of alcohol, tobacco and other drugs effects, pregnancy and sexually transmitted diseases prevention, responsible parenthood and positive social habits. During fiscal year 2012-2013, a total of 250 participants and 110 parents benefited from the program through its five programmatic areas: sports and recreation, arts, health and lifestyles, career and education developments, and character and leadership development.
