2. The following Articles of the Articles of Incorporation of this corporation have been amended to read as follows:

The introductory paragraph, "I, the undersigned, a natural person at least twenty-one years of age, desire to form a nonprofit nonstick corporation pursuant to the Nonprofit Public Benefit Corporation Law of the State of California, and do hereby certify as follows" - has been deleted.

The FIRST Article has been amended to read:

The name of the corporation is the Seventh Generation Fund for Indigenous Peoples (hereinafter referred to as the "Corporation").

The SECOND Article has been amended to read:

A. This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific purposes of the corporation are:

- (1) To engage in charitable activities related to improving the conditions, preserving the culture, and protecting the rights of Indigenous Peoples, communities/nations:

(a) to conduct and to sponsor programs of research, training and education in skills needed for such Indigenous communities/nations and to provide technical and financial assistance to local groups seeking to develop self-reliant Indigenous Peoples, communities/nations;

(b) to conduct and to sponsor workshops, meetings, and programs and to publish and distribute educational literature; and

(c) to conduct public education programs concerning the human, civil and other legal rights of Indigenous Peoples, and to provide advice and assistance to Indigenous People in matters affecting their general welfare and rights under the law.

- (2) to promote the development of economically self-sufficient Indigenous communities/nations.
- (3) to promote the spiritual, cultural and physical well-being of the Native family through assisting the charitable activities and projects that are initiated and controlled by Indigenous women.
- (4) to support and assist other organizations that are organized and operated for similar purposes, and to promote, encourage and foster other similar charitable activities.

- (5) to do any and all lawful acts and things which may be necessary, useful, suitable, or proper for the furtherance or accomplishment of the purposes of the Corporation.
- (6) to accept, hold, invest, reinvest and administer any gifts, legacies, bequests, devises, funds, and property of any sort or nature, and to use, spend, or donate the income of principal thereof for, and to devote the same to, the foregoing purposes of the Corporation.

The THIRD, FOURTH AND FIFTH Articles remain unchanged.

The SIXTH Article has been amended to read as follows: Upon the dissolution of the Corporation, after the Board of Directors has made provision for the payment of all of the debts and liabilities of the Corporation, all remaining property and assets of the Corporation shall be distributed either by direct distribution for the tax-exempt purposes of the Corporation (as set forth in Article SECOND hereof), or to one or more organizations which shall comply with all of the following conditions:

- (a) Such organization shall be organized and operate exclusively for charitable purposes, with its principal emphasis on issues of concern to Indigenous Peoples;
- (b) Such organization shall be exempt from Federal income taxation under Code Section 501(a) as an organization described in Code Section 501 (c)(3); and
- (c) Contributions to such organization shall be deductible under Code Section 170 (c)(2).

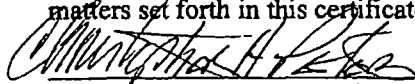
Any such assets not so distributed within a reasonable period of time after the dissolution of the Corporation shall be disposed of in accordance with the direction of any court having jurisdiction in the county in which the principal office of the Corporation last was located, exclusively in such a manner as in the judgment of such court will best accomplish the purposes for which the Corporation was formed.

None of the property of the Corporation nor any proceeds thereof shall be distributed or divided among any of the directors or officers of the Corporation or inure to the benefit of any individual.

The SEVENTH, EIGHTH, NINTH, TENTH and ELEVENTH Articles remain unchanged.

- 4. The corporation has no members.

Articles of Incorporation,

FIRST: The name of the corporation is The Seventh Generation Fund for Indigenous Peoples (hereinafter referred to as the "Corporation").

SECOND: A. This Corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

B. The specific purposes of the corporation are:

(1) to engage in charitable activities related to improving the conditions, preserving the culture, and protecting the rights of Indigenous communities/nations:

(a) to conduct and to sponsor programs of research, training and education in skills needed for such Indigenous communities/nations and to provide technical and financial assistance to local groups seeking to develop self-reliant Indigenous communities/nations;

(b) to conduct and to sponsor workshops, meetings, and programs and to publish and distribute educational literature; and

(c) to conduct public education programs concerning the human, civil and other legal rights of Indigenous Peoples

communities/nations, and to provide advice and assistance to Indigenous people in matters affecting their general welfare and rights under the law.

(2) to promote the development of economically self-sufficient Indigenous communities/nations.

(6) to accept, hold, invest, reinvest and administer any gifts, legacies, bequests, devises, funds, and property of any sort or nature, and to use, spend, or donate the income of principal thereof for, and to devote the same to, the foregoing purposes of the Corporation.

THIRD: The name and address in the state of California of the Initial agent of the Corporation for the service of process is Daniel R. Bomberry, 6450 First Street, Forrestville, California 95436.

FOURTH: A. The Corporation is organized and operated exclusively for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1945, as amended (hereinafter "Code Section").

B. No substantial part of the activities of the Corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign (including publishing or distributing or statements) on behalf of or in opposition to any candidate for public office.

FIFTH: The property of the Corporation is irrevocably dedicated to charitable purposes and no part of the net earnings or assets of the Corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons except that the Corporation shall, however, be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the Article SECOND hereof.

SEVENTH: Notwithstanding any other provision of these Articles, the Corporation shall neither have nor exercise any power nor shall it engage directly or indirectly in any activity, that would invalidate its status as a corporation (a) which is exempt from Federal income taxation under Code Section 170(c)(2), 2055(a)(2) and 2522(a)(2).

EIGHTH: The conditions of membership in the Corporation, the rights, obligations and classification of its members, if any, shall be as provided in by the By-Laws of the Corporation.

NINTH: The manner of election or appointment of the Board of Directors of the Corporation shall be as provided in the By-Laws of the Corporation.

TENTH: All references herein to provisions of the Internal Revenue Code of 1954, as amended, shall be deemed to include both amendments thereto and statutes which succeed such provisions (i.e., the corresponding provisions of future United States Internal Revenue Laws).
