Workforce Investment Activities - provides workforce development services throughout Plumas, Lassen, Modoc, Sierra and Butte Counties in Northern California. These services include a broad range of workforce development and community centered initiatives. This year, 99,916 individuals accessed the many services available at our 7 One Stop Employment Centers. Our goal each year is to meet the needs of our communities by outreaching and providing services to as many businesses and job seekers as possible. The number of individuals requiring additional services, beyond Universal Services, and enrollment into the WIA programs was 1,226. Our entered employment rate for individuals enrolled in our programs was 80.29%, with an average wage at placement of \$12.64.
