28 The mission of DEBATE-Kansas City (DKC) is to improve academic performance and increase opportunities for urban students through participation in debate. This year, DKC provided policy debate and student congress services to 5 school districts and 4 charter schools, in 25 high schools and middle schools, with 31 debate teacher/coaches, and 460 students. Direct on-location support was provided over 200 times and included coach mentoring, in-class presentations, after-school practices, curriculum development, evidence preparation, tournament support, and student coaching. DKC events for the year included five all-day professional development retreats for coaches training, 2 student workshops, 13 debate tournaments, and a year-end student awards and recognition ceremony. DKC published original documents including debate research files, comprehensive progress reports for each school district, progress reports for key stakeholders, informational website, and original debate curricula for both middle and high schools. DKC helps urban students beat the odds by increasing literacy, critical thinking skills, chances for graduation, and opportunities to attend college. A recent independent research report showed that debate increases high school graduation rates and college readiness for urban students.
