ARTICLE IX.

The Board of Directors of The Arc Caddo-Bossier, Inc. shall have no right to approve the members of the Board of Trustees elected through the By-Laws of the Corporation, nor shall the Board of Directors of The Arc Caddo-Bossier, Inc. have the right to approve amendments to the By-Laws and Articles of Incorporation or require the dissolution of the Corporation. Any amendments to the By-Laws and Articles of Incorporation of this Corporation or the dissolution of this Corporation shall require an affirmative vote of three-fourths (3/4ths) of the members of the Board of Trustees of this Corporation.

ARTICLE X.

In the event of the dissolution of the Corporation or in the winding up of its affairs, or other liquidation of its assets, the Corporation's property shall not be conveyed to any organization created or operated for profit or to any individual for less than the fair market value of such property; all assets remaining after all debts and expenses of the Corporation have been paid or provided for shall be conveyed or distributed by the Board of Trustees to one or more organizations qualifying for the exemption afforded by Section 501(c)(3) of the Code, and, if possible and practical, to the Association, or if not allowable, to an organization or organizations created and operated for nonprofit purposes similar to those of the Association. Any such assets not so distributed shall be disposed of pursuant to an Order by a Court of competent jurisdiction, exclusively for such purposes or to such organization or organizations, as the Court shall determine.
