Clinic Services: MHSSO provides treatment for the most challenging and complex mental illness and substance abuse issues. Our clinic staff assesses, diagnose, and develop individualized treatment plans for each person served. Psychiatric services are complemented with care/case management. Group and individual counseling services and other interventions as identified in the treatment plan, all conducted by fully licensed personnel. Rehabilitation services are provided in both individual and group settings to assist with the development of daily living/recovery skills. Consumers participating in the Psycho-social Rehabilitation (PSR) program are provided with transportation and participate in a "work ordered day" that further efforts at recovery.

4b (Code) (Expenses \$ **103,548** including grants of \$) (Revenue \$)

Residential Treatment Center: Our adult living facility is licensed by the state of Oklahoma Department of Health and Certified by the Oklahoma Department of Mental and Substance Abuse Services as an "enhanced" care setting. In addition to housing, mental health services coordinated with the local mental health clinic, may include group and individual therapy sessions and psychiatric care consistent with the individualized treatment plan. Consumers are assisted with personal hygiene, housekeeping, as well as monitored medication management. Treatment plans typically include Psycho-Social Rehabilitation services provided by MHSSO

4c (Code) (Expenses \$ **422,830** including grants of \$) (Revenue \$)

Crisis Diversion: 24-hour emergency on call system for psychiatric emergencies. A Qualified Mental Health Professional (QMHP) is available to assess persons in crisis and determine if they need psychiatric hospitalization or if services can be safely provided in the community. The goal of Crisis Diversion Services is hospital diversion, by appropriately assessing the consumer's needs, and providing him/her immediate access to community resources and treatment services as appropriate.

Drug Court: Under the supervision of the judiciary, and in cooperation with local law enforcement, MHSSO provides the treatment element to assist non-violent offenders as they pursue recovery and become productive citizens in the local community. Court-order drug-rehabilitation programs help abusing offenders break the cycle of addiction and the crime that accompanies it.

Systems of Care: "SOC" is a voluntary "wrap around" plan for children who are seriously emotionally disturbed (SED), or at risk of SED, and their families. possible. MHSSO recognizes that a stable, supportive environment is critical to the well being and successful treatment of persons with severe mental illness. The Crisis Stabilization Unit (CSU) will be co-occurring capable and assist persons with co-occurring disorders.

II. PROGRAM DESCRIPTION:

The CSU specializes in the crisis treatment of individuals on an emergency detention or voluntary admit. The facility has sixteen (16) beds and

crisis stabilization services twenty-four (24) hours a day, seven (7) days a week.

The CSU also has an urgent care component for individuals needing short term crisis intervention on a voluntary basis for less than twenty-four (24) hours. The urgent care component has six (6) recliners. The goal of the urgent care is to provide short term crisis intervention so that individuals will not need an emergency detention stay if possible.

Program staff have specialized knowledge of and training in crisis care. Staff include a Program manager, registered nurses, case managers, Licensed Behavioral Health Practitioners (LBHP), Recovery Support Specialists, Psychiatric technicians, and a consulting physician.

Clinical services are provided by professional staff and may include assessment, treatment planning, therapy services, case management,

IV. PROGRAM ELIGIBILITY:

A. Admission Criteria:

1. Person is under emergency detention status due to a serious mental illness (SMI) or co-occurring mental illness and substance abuse.

2. Person is assessed as needing voluntary placement for crisis needs in the CSU or urgent care component.

3. Person is eighteen (18) years of age or older.

B. Exclusion Criteria:

1. Person suffers from physical conditions that are beyond the scope of management in the CSU.

2. Person is under eighteen (18) years of age.

V. PROGRAM LENGTH OF STAY NORMS:

Lengths of stays are likely to be 5-10 days depending on the needs of the individual and pending court hearings. Urgent Care component stays are less than twenty-four (24) hours

VI. PROGRAM GOALS:

The goal of the CSU is to provide a supportive environment in order to manage the crisis stabilization of an individual. Individuals may be sent elsewhere for longer term stays if the person is determined to be in further need of treatment. Upon discharge from the CSU, individuals are linked with outpatient services in their area for continued support and treatment.
