The event, a banquet to honor outstanding Duncan Public Schools alumni, is open to the general public and widely attended, resulting in the major consistent funding vehicle for the Foundation's projects.

The Foundation's board of directors includes wide representation from various servants to the community (see attached). In addition, the Superintendent and Assistant Superintendent of Duncan Public Schools serve as integral parts of the board as ex-officio members. Also, non-board members (typically current or retired Duncan Public Schools employees) serve each year as voting members of the Grants Committee.
