THE BUSINESS MANAGER IS EVALUATED USING THE SAME MECHANISM /TOOL AS THE REST OF THE STAFF. COMPENSATION HAS HISTORICALLY BEEN ADJUSTED WITH A SLIGHT COST OF LIVING ADJUSTMENT THAT IS DETERMINED BY THE BOARD AS A WHOLE TO APPLY TO THE FACULTY AS A WHOLE.
