Grants to Baylor Medical Center at Irving: Irving Healthcare Foundation (IHF) granted over \$1,400,000 to Baylor Medical Center at Irving, the city's only non-profit hospital and the primary health care resource for residents and visitors. Grants included \$136,860 for cancer related services, \$151,000 for continuing education of nursing and allied health staff, \$5,600 for volunteer services, \$9,800 for the Congestive Heart Failure Clinic and education of the staff, \$8,100 for Community Outreach efforts, and \$5,000 for chaplaincy related programs. In addition, IHF also granted more than \$895,000 to renovate the hospital's emergency department and over \$200,000 to support indigent care.

Grants to Our Children's House at Baylor-Irving: IHF granted more than \$190,000 to Our Children's House at Baylor Irving (OCHI), an outpatient pediatric therapy clinic with integrated therapy services for children with medical and developmental needs. OCHI serves 30 children with medical or developmental needs through specialized, integrated care and therapy programs.

Grants to Irving Interfaith Clinic: IHF granted more than \$335,000 to Irving Interfaith Clinic (IIC), the only free charity clinic staffed by volunteer nurses, doctors, and dentists in Irving, Texas. IIC serves low-income and uninsured Irving residents.

Grants to Other IHF Beneficiaries: IHF granted \$153,000 for efforts to battle childhood obesity in Irving schoolchildren. IHF also granted \$11,000 to fund dental services for seniors and children at a local charity dental clinic. Additionally, IHF granted \$32,000 to the Baylor Health Care System Foundation.
