During the year ending June 30, 2013, the Blessing program provided 6,503,673 servings of nutritional support to 48,412 children in 30 countries.

 MannaRelief operates the Hope program that focuses on providing spiritual encouragement and an integrative approach to health through nutritional supplements to children under the age of 19. Children selected for the program receive monthly nutritional products. Additionally, the families receive spiritual support from the staff of MannaRelief. During the year ending June 30, 2013, the Hope program was able to provide 2,147,397 servings to 575 Hope children in 12 countries.
