Lead Agency - The Coalition for the Homeless of Houston/Harris County serves as the lead agency for the Continuum of Care planning and funding for Houston, Harris County and Fort Bend County Included in these activities are the annual Point in Time Homeless Count, the Homeless Services Coordinating Council (HSCC), the Consumer Advisory Council (CAC), Permanent Supportive Housing (PSH), and the Continuum of Care Collaborative Grant Application Point in Time Homeless Count - In January, the Coalition led the community’s efforts to obtain a one-night count of the sheltered and unsheltered homeless population in Houston, Harris County and Fort Bend County Using an Enhanced Point in Time Methodology which was developed in 2011, the count is based on the approved observational count model and complete canvassing of the region Volunteer participation increased from 450 in 2012 to over 500 in 2013 The area was divided into 29 separate study areas and was canvassed Ten staging areas were used The sheltered count was generated from HMIS data and verified by personal outreach Homeless Services Coordinating Council (HSCC) - the Homeless Services Coordinating Council meets monthly with an average attendance of 80 stakeholders The Coordinating Council members receive training, networking and give input on policy and governance issues of the Continuum of Care The HSCC elects two provider members - one representing crisis services and one representing housing - to represent them on the Continuum of Care Steering Committee Consumer Advisory Council (CAC) - The Consumer Advisory Council meets on the fourth Friday of every month and gave valued consumer input to the CoC Consumer members are current or formally homeless individuals including those currently residing on the street, in shelters or in a housing program The CAC is staffed by the Coalition The CAC also supports quarterly Consumer Input Forums which gather 50-75 currently homeless individuals to gather input on proposed policy and system change plans Permanent Supportive Housing (PSH) - Permanent Supportive Housing has been identified as the best intervention for long-term, chronic homeless individuals This housing model not only provides subsidized housing for an individual but is partnered with wrap around services to provide the support needed for that client to stabilize and stay housed successfully The Coalition offered trainings to the area service providers so that they better understood the model The Coalition also created a Pipeline Committee of funders who identified how many PSH units were currently in inventory and how many would be needed for our chronic population The Pipeline Committee continues to oversee the inventory and direct new funding, when possible, to the creation of the needed new units Continuum of Care Collaborative Grant Application - One major role of the lead agency is to submit a collaborative grant each year to HUD on behalf of all local service provider agencies for funding to support housing, services and HMIS In 2012, the grant was collapsed from three programs to one - the CoC grant In 2012, HUD also announced that all local areas should expect a 5% cut in funding and required the grant to divide its programs into Tier 1 and Tier 2 programs The Coalition worked with the community and with the CoC Steering Committee to determine priorities so that the programs requesting renewal funds and those requesting new funds could be split into the tiers The Houston/Harris County grant was the only one in Texas to be fully funded as submitted including the addition of three new programs for a total of over \$25 million shared by over 30 agencies funding over 60 programs

HMIS - The Homeless Management Information System (HMIS) is a computerized data collection tool specifically designed to capture client-level, system-wide information over time on the characteristics and services needs of men, women, and children experiencing homelessness HMIS allows the aggregation of client-level data across homeless service agencies to generate unduplicated counts and service patterns of clients served The Coalition for the Homeless of Houston/Harris County is the local HMIS lead agency In the second quarter of 2013, there were 61 partner agencies participating in HMIS with 412 active users The HMIS data was used for the 2012 Annual Homeless Assessment Report (AHAR) which was submitted to the Department of Housing and Urban Development (HUD) in January 2013 All reporting categories for the City of Houston’s area coverage were submitted and accepted by HUD The Coalition HMIS staff provide a variety of trainings each month including new user training, refresher courses, and reporting classes The staff also makes site visits and holds webinars both of which focus on data quality and privacy/security standards A new, key activity in 2012-2013 was the creation of an HMIS Support Committee composed of a representative from each type of programming, funding type and population served, i.e. housing, services, government, consumers, shelter, which meets monthly to review and make recommendations on improvements for HMIS

Homeless Services - The Coalition provides four programs to service providers which can be used to support homeless individuals - Homeless CourtCommunity Voice Mail, Information & Referral and In Memoriam Homeless Court - Homeless Court (HC) is a special court within the City of Houston Municipal Courts It is held weekly for homeless defendants to resolve outstanding misdemeanor offenses and warrants HC builds on partnerships between the court and local service provider agencies It works to resolve the problems homelessness presents with practical solutions Initial referrals to HC originate at the service provider agency level and are sent to the Coalition Court staff pulls dockets, and court dates are set by the presiding judge From July 2012 through June 2013, 435 clients appeared and 1,435 cases were resolved, thereby, removing one of the barriers faced by homeless individuals as they search for housing and employment Community Voice Mail - Community Voice Mail (CVM) provides free voice mail service to people without phones who are seeking jobs, housing, health care, safety and stability The Coalition offers this program to enable phoneless people to communicate with potential employers, landlords, human service providers, and doctors Between July 2012 and July 2013, CVM served hundreds of homeless clients monthly through over 100 service providers In Memoriam - On the longest night of the year, December 21st, a memorial service is held on the steps of City Hall in order to remember all those who died during the calendar year while being homeless In December, 2012, over 500 people, mostly homeless individuals gathered for a meal and a candlelight vigil during which over 50 names were read of those who died in 2012 Following the vigil, service provider agencies distribute coats, blankets, socks and other necessities to those who will then go spend a long, lonely night sleeping on the streets of Houston



Other direct assistance was used to purchase WalMart gift cards, Kroger gift cards, etc. Then a specified amount of these gift cards were distributed to the organizations to be used by the case managers in helping the homeless individual purchase items needed to set up housekeeping.
