	Goal 1 Advance public policy and systems change through the Partnerships leadership and activism The Partnership continued to work with our regional Public Policy and Research Committees (PPRCs) to inform policy-makers and the public about domestic violence-related policies In addition, we advocated for institutional reforms and systems changes through our representation on a number of multi-disciplinary committees and advisory groups including Providing information, educational materials, training and technical assistance regarding the courts role in responding to domestic violence through collaboration with the Administrative Office of the Courts Center for Families, Children and the Courts The Partnership serves on the AOCs Violence Against Women Education Project committee, as well as the Beyond the Bench judicial conference planning committee The Partnership continued to serve on the California Leadership Group on Domestic Violence and Child Maltreatment where we collaborated with the Department of Human Services to release a Special Topic Report on Domestic Violence in Families Served by Child Welfare Services in the State of California Partnership staff also represented the Leadership Group on a related committee the State Interagency Teams Home Visitation Workgroup, a project of the California Department of Public Healths Maternal, Child and Adolescent Health Division The Partnership continued to collaborate with related advocacy groups on policy issues pertaining to immigrants experiencing domestic violence including Secure Communities as well as the Trust Act Partnership staff also participated in the California Immigrant Policy Centers 17th annual Immigrant Day educating policy-makers at the Capitol and networking with advocates from related social justice movements The Partnership attended the California Emergency Management Agency's Domestic Violence Advisory Committee and continued to serve on Cal EMAs VAWA Implementation Plan Committee We also served on the California Victim Compensation and Government Claims Board Goal 2 Strengthen and promote the Partnerships collective voice on domestic violence The Partnerships communication efforts this year extended our organizational branding and information-sharing activities including Utilization of branding guidelines and materials, as well as the preparation and dissemination of our 2012 Annual Report In addition, we made 115 posts on our Facebook page, have 1,909 Facebook fans, and tweeted 382 times via our Twitter account during this year Issuing 17 press releases, advisories and media statements We continued to utilize technology to facilitate communications with our members and allied partners across the state, including our bi-monthly Information and Updates, as well as periodic Action Alerts, electronic awareness month toolkits and other stand-alone messages We posted additional content to our website and made revisions throughout the year During this period there were over 900,000 hits to this site We also launched our secure, members-only website last reporting period with the posting of our Sample 40-hour Curriculum (over 8,000 views of this curriculum thus far) The Partnership also developed and disseminated materials and resources for four awareness months Domestic Violence Awareness Month in October, Stalking Awareness Month in January, Human Trafficking Awareness Month in January, and Teen Dating Violence Awareness & Prevention Month in February Goal 3 Support and strengthen domestic violence programs, organizations and advocates throughout the state The Partnership developed and provided training, technical assistance and resources for domestic violence service providers, advocates and allied organizations throughout the year including 160 individuals attended our Annual Membership Meeting the theme of which centered on developing movement leadership and building beloved community Providing 34 trainings and webinars on a variety of domestic violence-related topics Over 1,420 individuals participated in these trainings and webinars The Partnership collaborated with the California Emergency Management Agency to conduct a series of regional trainings for local programs resulting in six trainings attended by 156 individuals last year Our Cross-training Sub-committee completed implementation of its training initiative with a final regional training in Riverside to 70 attendees This cross-training also enhanced collaborations with the California District Attorneys Association who signed on as an official co-sponsor of this training series, promoted it to their members and provided MCLEs to attendees The Partnership continued to serve on two advisory groups for the California Department of Public Health their Domestic Violence Primary Prevention Technical Assistance and Training project (DVPPTAT), and their Teen Dating Violence Committee (TDV Committee) CDPH also contracted with the Partnership to develop core competency guidelines for prevention advocates along with a foundational curriculum to support the development of consistent knowledge and skills for prevention educators across the state The Partnership also responded to 291 requests for technical assistance TA requests/calls came from domestic violence service providers, dual DV/SA providers and sexual assault advocates (45%, 10% and 1%, respectively) With regard to the nature of the requests, 40% of inquiries pertained to responses to victims/survivors (domestic violence, sexual assault, stalking, etc) while 12% related to organizational development and programmatic operational issues We distributed 100 financial literacy training curricula and other materials during in-person trainings and events We also supported advocates professional development through facilitation of several peer-networking activities Our Regional Representatives facilitated networking opportunities for domestic violence service providers, advocates and other allies throughout the State The Partnership continued peer networking calls providing monthly opportunities for advocates from multiple roles to learn from and connect with peers throughout the state The Shelter Managers calls engaged 139 individuals and 54 Bilingual/Bicultural Advocates participated in calls Programs also benefitted from learning exchange opportunities via the 9 electronic listservs we maintained, the most active of which was our Shelter Network Listserv (with a total of 185 subscribers, 36 new subscribers , and 617 new posts made during this reporting period)
