AMERICAVIEW (WWW.AMERICAVIEW.ORG) IS A NATIONWIDE CONSORTIUM THAT FOCUSES IN SATELLITE REMOTE SENSING DATA AND TECHNOLOGIES IN SUPPORT OF APPLIED RESEARCH, K-16 EDUCATION, WORKFORCE DEVELOPMENT, AND TECHNOLOGY TRANSFER. AMERICAVIEW'S MEMBERSHIP OBJECTIVE IS THE DEVELOPMENT OF REMOTE SENSING CONSORTIA IN EVERY PARTICIPATING STATE, SUCH THAT THE ORGANIZATION BECOMES A NATIONALLY COORDINATED CONSORTIUM OF LOCALLY-CONTROLLED STATE-LEVEL CONSORTIA. AS OF JUNE 30, 2013, 31 STATES WERE FULL MEMBERS, 3 STATES WERE ASSOCIATE MEMBERS, AND 5 STATES WERE AFFILIATES. THIS TAX YEAR, AMERICAVIEW AWARDED BASE FUNDING VIA SUB-AWARDS TO 31 MEMBER UNIVERSITIES.
