

Form 990, Part VI, Section B, Line 15A: In determining compensation for the Executive Director, comparability and performance review are used to determine annual compensation. There is no outside, independent review.

Form 990, Part VI, Section c, Line 19: YCFI makes all governing documents, policies, and financial statements available to the public. All YCFI meetings (10 meetings are held per calendar year) are open to the public and it is during these meetings that all documents are discussed. All documents and financial statements are provided to any party/person that makes a request in writing.
