182 adults (16 or older and not enrolled in public school) received direct instruction to enable them to function on the job, within their families, and in society. 49 students completed their high school equivalency diploma, or GED. 11 Students entered postsecondary education or training right away. 17 students entered employment and 31 retained employment.

Explanation of grants: 16 students received scholarships for the cost of the GED testing fee @ \$55 each. One student received a scholarship for the \$7 retest fee. One student received a \$1000 scholarship for postsecondary education.

The GED testing scholarship checks were made out to the testing center so they could not be used for any other purpose.

The postsecondary scholarship check was made out to the college and the student and sent to the college for deposit.

English Language/Civics instruction for 17 adults seeking to speak English better and to become participants in the community or to gain citizenship.

Family literacy activities included: Workshops for 21 parents of preschool children, story times for more than 300 children, and 574 new books were distributed to needy children. Volunteers staff this project.
