FOR THE FISCAL YEAR ENDED JUNE 30, 2012, THE VOLUNTEER TREASURER OF THE BOARD DECIDED TO TAKE ON THE RESPONSIBILITY TO PREPARE AND FILE FORM 990 HERSELF. SHE PREPARED BOTH EXTENSIONS FOR THE FORM 990. HOWEVER, SHE EXPERIENCED A NUMBER OF CRISES IN HER PERSONAL LIFE, INCLUDING A DIVORCE AND JOB CHANGE, WHICH RESULTED IN HER FAILING TO TIMELY FILE THE FORM 990. SHE EVENTUALLY RESIGNED HER POSITION AS THE TREASURER OF THE ENTITY, AS SHE WAS HAVING DIFFICULTY IN FULFILING HER RESPONSIBILITIES. FURTHER, SHE FAILED TO NOTIFY THE BOARD OR THE EXECUTIVE DIRECTOR OF THE FACT THE FORMS 990 WERE NOT FILED FOR FYE 2012 NOR FYE 2013. THUS, THE BOARD OF DIRECTORS WAS UNDER THE IMPRESSION THE FORMS 990 HAD BEEN TIMELY FILED. THIS WAS THE ASSUMPTION OF THE BOARD UNTIL 2014 WHEN THE ENTITY'S NEW ACCOUNTING FIRM REQUESTED A COPY OF THE FORM 990 AS PART THE FINANCIAL AUDIT IT WAS PERFORMING FOR THE ENTITY'S FISCAL YEAR ENDING IN 2013. THE BOARD WAS UNABLE TO LOCATE COPIES OF THE FORMS 990 SO THE IRS WAS CONTACTED TO DETERMINE IF THE FORMS 990 HAD BEEN FILED. THE BOARD LEARNED FROM THE IRS THAT NO FORM 990 FOR FYE 2012 NOR FYE 2013 HAD BEEN FILED. THE BOARD IMMEDIATELY REQUESTED THE ENTITY'S NEW ACCOUNTING FIRM TO ASSIST IN THE PREPARATION AND FILING OF THE FORMS 990. ALSO, TO FURTHER COMPLICATE THE MATTER, THERE WAS A CHANGE IN THE EXECUTIVE DIRECTOR POSITION OF HELP, INC. BETWEEN THE TIME OF THE LAST FILING OF ITS FORM 990 WITH THE IRS AND THE TIME OF DISCOVERY OF THE LATE FILING. TO PREVENT SUCH A MISHAP FROM TAKING PLACE AGAIN, THE BOARD & NEW EXECUTIVE DIRECTOR WILL CONTINUE TO HAVE THE FORM 990 PREPARED BY THE ACCOUNTING FIRM HIRED TO PERFORM THE ANNUAL FINANCIAL STATEMENT AUDIT. FURTHER, THEY WILL MORE ACTIVELY MONITOR THE STATUS OF THE PREPARATION AND FILING OF THE FORM 990 AND COPIES OF THE DRAFT FORM 990 WILL BE REVIEWED BY BOARD MEMBERS PRIOR TO THE FILING TO MAKE SURE THAT THE ENTITY IS IN COMPLIANCE WITH ITS FILING REQUIREMENTS.
