Throughout the fiscal year the Foundation has raised funds to support various projects for its supported organization, WMC (Wyoming Medical Center) The WMC Foundation's overall goal is to raise \$3 million towards the new McMurry West Tower Throughout the past year the Foundation raised over \$1 million to be designated towards the new patient tower of the hospital which is a \$43.5 million project The new McMurry West Tower will enhance services provided to the more than 85,000 patients that Wyoming Medical Center serves on a yearly basis To date, the Foundation has commitments towards the project totaling \$2.6 million Our goal is to be completed with the campaign by summer of 2014 The WMC Foundation raises funds to continue to support the Masterson Place, a 30 bed hospitality home utilized for patients and families who travel to Casper, Wyoming to receive medical treatment and need a place to stay The Masterson Place offers families a \$40.00/night rate, however if they are unable to afford the \$40.00 rate, the WMC Foundation helps to scholarship patients in need This past year the goal for the Masterson Place was to serve over 5,500 patients and families at the Masterson Place The Masterson Place exceeded its goal and served over 5,800 patients and families in need with over 800 of those being cancer patients that travel to Casper for chemo/radiation treatment The WMC Foundation also raised funds in the fiscal year 2013 to support the completion of the WMC Emergency Room In fiscal year 2013 the Foundation disbursed \$750,000 for this project

Angels Cancer Care Program The Angels program provides support to cancer patients that are currently receiving treatment The Angel volunteers are cancer survivors, friends, family and community members Support for cancer patients can be medication, wigs, food and gas cards, hotel stay, meals, and more This past year the Angels' goal was to serve 500 patients undergoing treatment with direct needs The Angels exceeded their goal and served a total of 1,198 cancer patients as well as held several fundraisers to raise over \$60,000 for the program
