Grants made to Denver Public Schools (DPS) to support its relentless pursuit of student achievement impacted several key areas of focus including school innovation, leadership development, athletic programs, tutoring, literacy, grants to classrooms and schools, science, technology, engineering and math (STEM) education, health and wellness and after-school programs DPS Foundation grants are in direct service to DPS students, schools, teachers and leaders Denver Public Schools serves over 84,000 students in 174 schools See continuation on Schedule O DPS Foundation partnered with foundations, corporations, parents, employees, alumni and other members of the community to support programs and schools district-wide Supported by our ever-increasing donor base, DPS Foundation is helping address the challenges facing our public school system by granting over \$13.6 million to DPS for priority programs and critical needs in fiscal year 2012-13, an increase of approximately 10% from 2011-12 Gifts to DPS Foundation have tangible and lasting impact in our schools This was especially evident in 2012-13 Donor funding supported programs including targeting tutoring, which helped enrolled students advance as much as two grade levels in a single year, standardized science curriculum, which has facilitated an 11% increase in DPS fifth-grade science scores since it was implemented in 2007, and an after-school program for 700 DPS students which provided an enriching after-school experience, 20,000 healthy dinners and 11,000 "weekend backpacks" full of nutritious food to enrolled students in the 2012-2013 school year alone Thanks to our donors' generosity, DPS is implementing programs and strategies to address the greatest priority areas and needs in our schools As a result, DPS students have posted the highest year-to-year growth among Colorado's 20 largest districts for the last several years The percentage of DPS third-graders who are proficient or advanced in reading has climbed 10% since 2010 In seven years, the on-time graduation rate has risen 30%, while dropout rates have been cut in half DPS is the fastest growing urban school district in America, growing enrollment by 10,000 students while Denver's population has remained flat
