Denver Rescue Mission and Outreach Services DRM provides food boxes, clothing, counseling, education, furniture, household goods, and temporary lodging to low-income families and individuals DRM’s Health Clinic provides basic medical care, optical and dental services, and chiropractic exams to program participants and the public Seasonal outreaches at Easter, Thanksgiving and Christmas provide enhanced services to both program participants and the public During the year ending June 30, 2013 the Denver Rescue Mission provided 616,306 meals, distributed 2,131 food boxes, distributed 124 tons of clothing, and provided 289,541 nights of shelter

The Crossing DRM provides 83 transitional living units at The Crossing for homeless working families and individuals in the STAR Transitional Program These families will pay rent and bills on time, save money, attend workshops, case management and counseling sessions, and locate permanent housing Through the New Life Program, which is implemented at The Crossing and three of our other facilities, DRM provides substance abuse rehabilitation for more than 230 men and women at all times The program emphasizes education, overcoming addictions, employment readiness, life-skills training and good work habits

Lawrence Street Shelter Lawrence Street Shelter is DRM’s ‘flagship’ facility that provides a safety net for homeless men, women, and children It is open 365 days a year to provide food, shelter, clothing, and health care to the needy All 200 beds are filled every night, and more than 100 additional cots and sleeping mats are used as needed DRM serves three hot meals daily to anyone Each meal served consists of six ounces of meat, four ounces of starch, and four ounces of vegetables

Harvest Farm Harvest Farm is the rural home of the New Life rehabilitation program for 72 men It sits on 209 acres and is a fully operating farm and ranch providing unique work therapy for program residents away from the temptations of the city The vegetables and meat grown there provide food for the Mission’s kitchens as well as the Wellington Food Bank

Champa House Champa House is DRM’s transitional housing facility for homeless, single mothers and their dependent children Many of the women living at Champa House were victims of domestic violence at some point in their lives and some are seeking substance abuse treatment and/or an opportunity to learn new life and education skills that will prepare them and their children for a life of self-sufficiency DRM’s Life-Skills, Education and Career (LEC) program provides these women with basic academic skills, vocational training, computer literacy, and important life skills such as Parenting, Budgeting, Health and Nutrition, Coping Skills (Anger Management), Domestic Skills, Healthy Relationships, Computer Skills, and Adkins Career Development

(Code) (Expenses \$ 439,033 including grants of \$ 179,646) (Revenue \$ 3,900)

Fort Collins Rescue Mission Denver Rescue Mission acquired the assets of Open Door Mission in Ft Collins, Colorado during November of 2012 and began operating as Fort Collins Rescue Mission The facility shelters 50 men and 25 women nightly, and serves breakfast and dinner daily to shelter guests DRM’s goal is to make a significant and positive impact on the homeless population in Ft Collins by offering the same quality services and programs like those at the Denver facilities
