About Our Organization

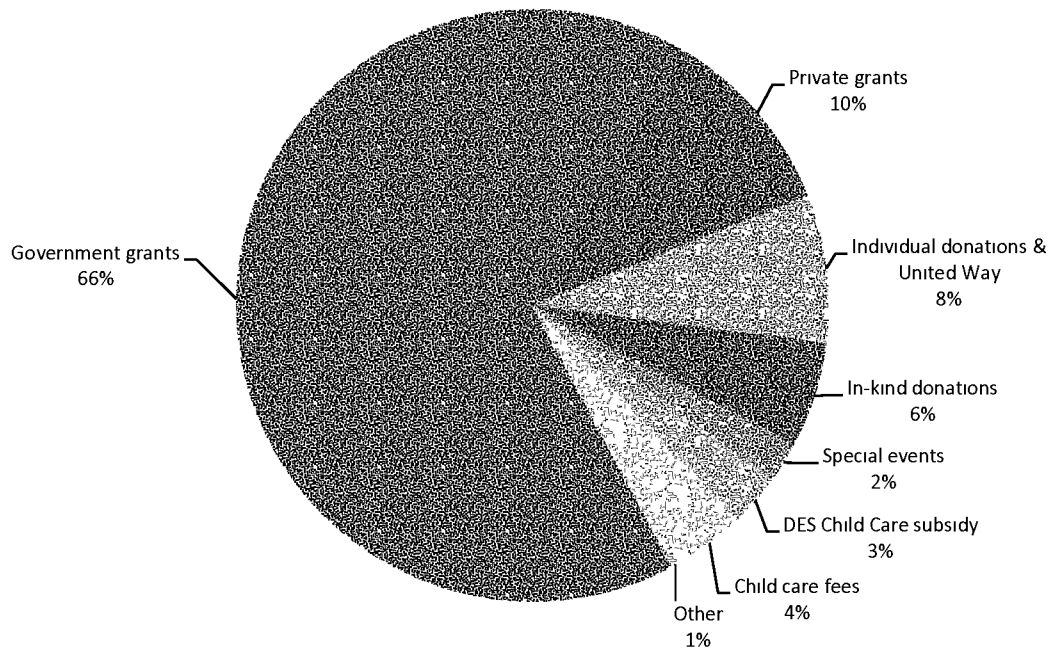
Emerge! Center Against Domestic Abuse was formed in 2008 by combining the best practices and long experience of two outstanding local domestic violence organizations: *Tucson Centers for Women and Children* which was founded in 1975; and *Brewster Center* which started in 1963 as a residence for unwed mothers, and in 1982 became a domestic violence shelter for women and children. To enhance our community's response to domestic abuse, the two agencies merged in 2008 to form the largest exclusive provider of domestic abuse services in Southern Arizona.

The mission of ***Emerge!*** is to provide the opportunity to create, sustain and celebrate a life free from abuse. We give people the tools to address abuse and build a new life that is good for themselves and their children. We work with those who are among the most vulnerable to serious injury or death in our community, helping them to leave dangerous situations safely and with support. We respond to the immediate crisis, and then assist them to heal from the trauma to create a more stable and satisfying life. While we will assist anyone impacted by intimate partner abuse, the vast majority of the population we serve is women and their children.

It takes a village of goodwill to end abuse. Through the combined support of our many donors and partners, during the last year *Emerge!* was able to accomplish the following:

- ***More than 3,500 people in our community increased their understanding about DV and how to respond safely*** by taking part in *Emerge!* community presentations and/or contacting the *Emerge!* hotline.
- ***Nearly 2,000 people -- including 1,330 adults and 645 children -- took action to deal with an abusive situation*** by using *Emerge!* services (coming to shelter or seeking help at one of our community-based programs).
- ***Emerge! helped people to survive and recover from abuse*** by providing:
 - Shelter to 849 people
 - Longer-term housing to 40 families
 - Case management assistance to 2,230 people
 - Crisis intervention counseling to 2,573 people
 - Lay legal services to 846 people
 - Life skills education to 1,201 people
 - Safety planning support to 2,904 people
 - Peer support groups for 840 people
 - Transportation for linkage to critical services to 569 people
- ***663 child survivors of abuse learned new ways of responding to conflict, trauma and/or abuse*** by participating in family services at *Emerge!*

All of our services are available in both English and Spanish. Aside from our Angel Children's Center which offers day care services both to *Emerge!* participants and the general public, there are no fees for our services. As shown below, the majority of the funding for our shelter and housing services comes from government sources; but it is the vitally important support from non-governmental groups that allows us to address the myriad issues faced by abuse survivors.



Our valued volunteers play a critical role at *Emerge!* Volunteers serve as hotline responders, shelter workers, child advocates, support specialists, in-kind donations assistants, community educators, and "odd-jobbers." During the past year, 277 volunteers contributed 5,456 hours of service which, when valued at \$12/hour, is a contribution equivalent to \$65,472. Volunteers are recruited from the community through Volunteer Southern Arizona, our *Emerge!* website, listserve mailings, and announcements at community events. In addition, many college interns in our community are able to get real-world learning opportunities at *Emerge!* through our partnerships with Arizona State University School of Social Work; UA Family Studies and Human Development Division, the Psychology and Sociology Departments, and the School of Anthropology; the Pima Community College Social Services Department; and University of Phoenix College of Health and Human Services. Volunteer recruitment occurs on an ongoing basis and is organized by our Volunteer Services Coordinator.
