With any arrest the caller receives up to \$1,000 in reward money. 88-Crime works closely with all media, which highlight fugitives, cold case homicides and other felony crimes by means of television, radio and newspapers. In addition, the organization collaborates with middle schools by providing visual materials and information to students to educate 5th through 8th graders how to anonymously contact 88-CRIME to report illegal or suspicious activities at their school.
