STEP UP is a charter school under Arizona Statute 15-101ET Seq with the tax exempt purpose of fulfilling state educational requirements. The ADM (average daily membership) decreased from 1191 students in grades K-8 to 58.6 in grades K-6.
On June 30, 2012, Edu-Prize, Inc. changed its' name to STEP UP SCHOOLS, Inc., and moved into Mesa to service a local neighborhood.

4b (Code:) (Expenses \$ 52,474 including grants of \$ -0-) (Revenue \$ -0-)
STEP UP offered a free all day kindergarten program servicing approximately 20 students for which half day funding was received. STEP UP also offered a free pre-k program in the community which serviced approximately 9 children.

4c (Code:) (Expenses \$ 25,100 including grants of \$ -0-) (Revenue \$ -0-)
STEP UP SCHOOLS offered an extended day and summer school program. This program extended the school day by up to 2 hours for students to stay on a voluntary basis, and was additionally carried out for 15 days during the summer for 4 hours per day.
