Each year, 15,000 to 17,000 homeless, low and moderate income individuals, their families and pets are served by providing 150,000 to 250,000 pounds of nutritious food/150,000 meals and household items, Christmas, Easter and Thanksgiving gifts in Las Vegas and Mesquite, Southern Nevada. The agency's wellness services allow seniors and people with disabilities to access non-medical home care services in their homes.

 The agency provides supportive housing, employment, case management and temporary financial assistance to homeless and low-income families. 
