The Agency's Community Nutrition Services allows people to select fresh produce and package food items themselves in a supermarket-style setting free of charge. Each year, 15,000 to 17,000 homeless, low and moderate income individuals, their families and pets are served by providing 150,000 to 250,000 pounds of nutritious food/150,000 meals and household items, Christmas, Easter and Thanksgiving gifts in Las Vegas and Mesquite, Southern Nevada. The agency's wellness services allow seniors and people with disabilities to access non-medical home care services in their homes.

The agency provides supportive housing, employment, case management and temporary financial assistance to homeless and low-income families.
