DURING FISCAL YEAR 2013, THE FAMILY CONNECTION CENTER CONSOLIDATED SEVERAL PROGRAMS INTO TWO UMBRELLA DEPARTMENTS, ELIMINATING TWO MIDDLE-MANAGEMENT POSITIONS THE TWO UMBRELLA DEPARTMENTS ARE (1) COMMUNITY ACTION (WHICH INCLUDES THE FOLLOWING PROGRAMS SELF-SUFFICIENCY SUPPORT, HOMELESSNESS PREVENTION, CRISIS PREVENTION, MOTEL VOUCHERS, THE FOOD BANK AND SUB-FOR- SANTA) AND (2) FAMILY SUPPORT (WHICH INCLUDES THE FOLLOWING PROGRAMS CRISIS NURSERY, RESPITE NURSERY, PARENT EDUCATION AND THERAPY) THIS PROVIDES FOR GREATER PROGRAM OVERSIGHT WITH FEWER MANAGEMENT STAFF FOR GREATER OVERALL FINANCIAL STABILITY OF THE ORGANIZATION THIS CONSOLIDATION WAS ABOUT TWO YEARS IN THE PLANNING, PREPARATION, AND IMPLEMENTATION AND HAS BEEN VERY SUCCESSFUL FAMILY CONNECTION CENTER WORKED CLOSELY WITH THE UTAH STATE COMMUNITY SERVICES OFFICE TO RE-TOOL OUR HOMELESS PROGRAM FROM A "TRANSITIONAL HOUSING" TO "RAPID RE-HOUSING" RESULTING IN A COMPLETELY RE-DESIGNED PROGRAM SERVING A MORE DIFFICULT TARGET POPULATION AND RECEIVING AN ADDITIONAL 70,000 IN STATE FUNDING AND TWO FOUNDATION GRANTS FOR 10,000 EACH IN SUPPORT OF OUR HOMELESSNESS PROGRAMS THE ASSISTANT EXECUTIVE DIRECTOR HAS BEEN TASKED TO PARTICIPATE IN THE DAVIS CHAMBER OF COMMERCE AND THE LEGISLATIVE AFFAIRS COMMITTEE WHICH HAS RESULTED IN STRONG PARTNERSHIPS, ADDITIONAL DONATIONS, GREATER MARKETING, AND ENHANCED UNDERSTANDING AT ALL LEVELS OF THE COMMUNITY ABOUT THE REAL IMPACT OF POVERTY IN DAVIS COUNTY WHILE THE FAMILY SUPPORT PROGRAMS HAVE OFTEN UTILIZED INTERNS, THE COMMUNITY ACTION PROGRAMS HAVE NOT UNTIL THIS YEAR THERE WERE ENOUGH GROWTH, LEARNING, AND BENEFITS TO EXPAND THE PROGRAM IN THE NEXT FISCAL YEAR
