Adult Community Conferencing-RJCA creates a forum in which people impacted by livability crimes meet with offenders who commit the crimes to discuss the impact and determine restitution. It is through these community forums that RJCA achieves its primary objectives of effectively addressing livability crime which helps prevent further crime and community deterioration while repairing the harm caused by criminal behavior. RJCA also provides opportunities for community-building by creating relationships within neighborhoods allowing people to work together to reinforce norms of acceptable behavior. As referred participants (offenders) recognize the impact of their behavior, they receive support and often times connect with the community in positive ways. In FY13, 356 adult offenders enrolled in RJCA out of 389 referrals (92% enrollment rate); 322 cases were conferenced out of 346 (93% attendance rate); and 308 successfully completed the program out of 348 closed cases (89% success rate). Referred participants completed 3,442 hours of community service, gave 207 apologies, and donated \$2,655 and 106 in-kind donations in the communities that were affected. They also completed 236 hours of self development activities such as working on education (GED) or writing reflection essays. Over 277 community member participations and 177 trained volunteer facilitations occurred by 121 volunteers who met face-to-face with the 322 conferenced cases.

Youth Community Conferencing--RJCA creates a forum in which people impacted by livability crimes meet with offenders who commit the crimes to discuss the impact and determine restitution. In FY13, 97 youth offenders enrolled in RJCA out of 126 referrals (77% enrollment rate); 77 cases were conferenced out of 83 (93% attendance rate); and 72 successfully completed the program out of 81 closed cases (89% success rate). Referred participants completed 445 hours of community service, gave 75 apologies, and donated 9 in-kind donations in the communities that were affected. They also completed 88 self development activities such as working with a tutor, creating a graduation plan, attending anger management classes or writing reflection essays. Over 110 community member participations, 19 trained volunteer facilitations occurred in the 77 cases conferenced. Along with the referred youth, 10 direct victims, 100 family members and 4 non family supporters met face-to-face with community members at the conferences.
