Pursuant to the provisions of the Washington Nonprofit Corporation Act, RCW 24.03, the following Articles of Amendment are submitted for filing for the purposes of amending the Articles of Incorporation of Washington State Migrant Council:

1. The name of the corporation is Washington State Migrant Council.
2. The Articles of Incorporation of the corporation are amended as follows:
 - a. Article I is amended to read as follows:

ARTICLE I

The name of the Corporation shall be Inspire Development Centers

- b. Article IV is amended to read as follows:

ARTICLE IV

This Corporation is organized and operated exclusively for charitable, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any further United States internal revenue law or successor statute ("Code"). Consistent with and subject to its qualification under Section 501(c)(3) of the Code, the corporation is organized and operated to:

(a) To provide migrant child development services and to initiate, and improve educational opportunities, vocational training, health services for children, youth and migrant, seasonal and rural poor families and other endeavors which hold promise of successfully elevating the quality of life of migrant families while they are in the state of Washington.

(b) To aid, support, and assist by gifts, contributions or otherwise, other corporations, community chests, funds and foundations located in the state of Washington and organized and operated exclusively for charitable, religious, scientific, literary or educational purposes, no part of the net earnings of which inures to the benefit of any private shareholder or individual, and no substantial part of the activities of which is carrying on propaganda, or otherwise attempting to influence legislation.

(c) To carry out any other lawful activity permitted under the laws of the State of Washington.

c. Article V and Article VI are each amended to delete every instance of the following phrase: "Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue Law" and replace each instance of the deleted language with "Code."

d. A new Article XI is added to read as follows:

ARTICLE XI

The corporation shall have all powers granted by law necessary and proper to carry out its above stated purposes, consistent with its qualification under Section 501(c)(3) of the Code.

e. A new Article XII is added to read as follows:

ARTICLE XII

To the full extent that Washington law, as it exists on the date hereof or may hereafter be amended, permits the limitation or elimination of the liability of directors, a director of this corporation shall not be liable to this corporation for monetary damages for conduct as a director. Any amendments to or repeal of this Article shall not adversely affect any right or protection of a director of this corporation for or with respect to any acts or omissions of such director occurring prior to such amendment or repeal.

f. A new Article XIII is added to read as follows:

ARTICLE XIII

This corporation has the power to indemnify (including the power to advance expenses to) its directors, officers, employees, and agents made a party to a proceeding, as defined in the Washington Business Corporation Act, without regard to the limitations in RCW 23B.08.510 through 23B.08.550; provided, however, that no such indemnity shall indemnify any such director, officer, employee, or agent from or on account of: (1) acts or omissions of such director, officer, employee, or agent finally adjudged to be intentional misconduct or a knowing violation of law; (2) conduct of the director, officer, employee, or agent finally adjudged to be in violation of RCW 23B.08.310; or (3) any transaction with respect to which it was finally adjudged that such director, officer, employee, or agent personally received a benefit in money, property, or services to which such person was not legally entitled.

3. There are no members, or no members having voting rights with regard to the foregoing amendments. The foregoing amendments were adopted at a meeting of the Board of Directors on January 25, 2013. The amendments received the vote of a majority of the directors in office.
