	The Agros program model is a unique and holistic approach to alleviating rural poverty. Agros provides a wide range of integrated services in food security, improved production and market access, community health and nutrition, primary education, financial services, and access to long-term loans for land ownership. In 2013, Agros provided comprehensive support to 17 rural communities (approximately 682 families and 4,092 individuals) in Guatemala, El Salvador, Mexico, Nicaragua, and Honduras, and three communities reached key development milestones and were graduated from direct Agros support. Agros provided income-generating technical assistance to more than 500 small producer families, mainly in basic grain, coffee, and vegetable production. Additionally, Agros launched a large-scale community health program in the region of Matagalpa, Nicaragua, providing essential healthcare to approximately 500 children and 470 mothers, and comprehensive training to more than 150 community health volunteers.
