The West Seattle Food Bank (WSFB) is a not-for-profit organization committed to providing food security and community connections to our neighbors in need WSFB distributes food, baby food, baby supplies, books and other items to low-income residents of West Seattle In fiscal year ending June 30, 2013 the agency provided food and other basic necessities to families in need 37,840 times, distributed 1,321,429 pounds of food, delivered 7,800 bags of groceries to elderly and disabled individuals, distributed over \$300,000 worth of baby supplies, 900 books, and thousands of pounds of pet food WSFB also collaborates to offer food distributions at other non-profit agencies in the area
