THE PRIMARY FOCUS OF THE YAKIMA ROTARY TRUST DURING THE 2012-13 FISCAL YEAR WAS A PARTNERSHIP WITH THE CITY OF YAKIMA PARKS AND RECREATION AND THE THREE LOCAL ROTARY CLUBS (YAKIMA ROTARY, YAKIMA SOUTHWEST ROTARY AND YAKIMA SUNRISE ROTARY) TO MAKE IMPROVEMENTS AT FRANKLIN PARK LOCATED IN YAKIMA, WASHINGTON. THE IMPROVEMENTS TO THE PARK INCLUDED THE CONSTRUCTION OF A ROTARY PAVILION, PLAYGROUND ADJACENT TO THE PAVILION, AND TWO PICNIC SHELTERS. FRANKLIN PARK COVERS APPROXIMATELY 18 ACRES AND IS THE #1 MOST USED PARK WITHIN THE CITY. IT IS SURROUNDED BY MOSTLY SINGLE FAMILY HOMES OCCUPIED BY A WIDE MIX OF FAMILIES OF VARIOUS ETHNIC BACKGROUNDS. IT IS ADJACENT TO A MIDDLE SCHOOL AND THE YAKIMA VALLEY MUSEUM, AND IS HOME TO SIX TENNIS COURTS AND THE CITY'S ONLY OUTDOOR COMMUNITY SWIMMING POOL. THE PAVILION PROVIDES THE COMMUNITY A PLACE TO ENJOY PERFORMANCES FOR YEARS TO COME WHILE THE ADJOINING PLAYGROUND AND PICNIC SHELTERS PROVIDE A SAFE FUN ENVIRONMENT FOR CHILDREN AND THEIR FAMILIES TO PLAY. ALL THREE ARE A TESTAMENT OF THE TRUST'S MISSION OF MAKING OUR COMMUNITY A BETTER PLACE TO LIVE.

THE TRUST IS ALSO ADMINISTERS A RENEWABLE SCHOLARSHIP ENTITLED THE MARY MONROE DAVIS SCHOLARSHIP PROGRAM THIS ANNUAL PROGRAM AWARDS SCHOLARSHIPS TO RESIDENTS OF YAKIMA COUNTY WHO PLAN TO CONTINUE THEIR EDUCATION IN UNDERGRADUATE STUDY RENEWABLE SCHOLARSHIPS FOR TUITION AND FEES ARE OFFERED EACH YEAR FOR FULL-TIME STUDY AT AN ACCREDITED TWO OR FOUR-YEAR COLLEGE OR UNIVERSITY OF THE STUDENT'S CHOICE DURING THE 2012-13 FISCAL YEAR, THE FOURTH YEAR OF THE PROGRAM, THE TRUST AWARDED 31 NEW SCHOLARSHIPS TOTALING \$219,000 THE TRUST ALSO PAID OUT \$459,890 IN RENEWABLE SCHOLARSHIPS
