		Client Note 1 - NAMI Walk - Washington State, a Fundraising Event for many agenciesThe annual fundraising event called NAMI Walk is a co-sponsored event with approximately 16 agencies sponsoring the event and sharing the funds raised The Washington State Affiliate, NAMI Washington, has overall management responsibility, but acts in an agency capacity in collecting and distributing proceeds for the other agencies Accordingly, NAMI Washington includes in its own gross revenues the gross proceeds minus the shares attributed to the other agencies Indirect expenses of the Walk include fees for the services of the Walk Manager, Marketing Coordinator, Event Coordinator and others, none of whom are professional fundraisers This agency accounts for and reports all of the costs of the event Direct costs are reported on Line 8b, Part VIII, Statement of Revenue Indirect costs are reported as fundraising expenses That causes this agency to report a disproportionately high amount of fundraising expenses, as the amount reported includes costs incurred on behalf of the co-sponsors
