Homeless Family Service The Homeless Family Services Program serves as the coordinated entry point for all homeless families with children in Thurston County, providing services such as emergency shelter screening and placement, housing assistance, rapid re-housing, case management, advocacy, outreach, computer, phone, and community voicemail access, employment, child care, and mental health resources, transportation, clothing, food, hygiene and emergency supplies The goal of this program is to help families obtain and maintain permanent housing, increase skill and income, and build greater self-sufficiency

Facilities Management The Family Support Center manages a 12,000 sq foot building, providing centralized and coordinated services for families with children by offering low cost rental space to other co-located nonprofit and government family and child service agencies
