WE ALSO AWARDED FOUR AWARDS TO DESERVING WOMEN. THE SCHOLARSHIP PROGRAM IS ADMINISTERED BY THE SCHOLARSHIP COMMITTEE, MADE UP OF CLUB MEMBERS. ALL SCHOLARSHIP APPLICATIONS ARE JUDGED BY A PANEL OF COMMUNITY VOLUNTEERS SELECTED ANNUALLY BY THE SCHOLARSHIP COMMITTEE. THE SCHOLARSHIP COMMITTEE AWARDS THE SCHOLARSHIPS BASED ON THE RECOMMENDATION OF THESE PANELS.

AWARDS ARE MADE BY THE AWARDS COMMITTEE AND THE HUMAN RIGHTS / STATUS OF WOMEN COMMITTEE. APPLICATIONS ARE SOLICITED FROM THE PUBLIC AND AWARDS MADE BASED ON THE APPLICATIONS. CONSIDERATION IS GIVEN TO COMMUNITY SERVICE, IMPACT ON WOMEN AND CHILDREN, NEED, AND EDUCATIONAL GOALS.

OUR MOST ACTIVE PROGRAMS ARE OUR COMMUNITY SERVICE PROGRAMS. DONATIONS ARE MADE TO CHARITIES, SCHOOLS, HOSPITALS ET AL, PRIMARILY IN ANACORTES AND SKAGIT COUNTY. THESE ARE AWARDED TO PROGRAMS THAT BENEFIT WOMEN AND CHILDREN. WE ALSO SUPPORT ORGANIZATIONS OUTSIDE OUR LOCAL AREA AS WE DEEM APPROPRIATE. ALL DONATIONS ARE GIVEN TO OTHER 501(C)(3) ORGANIZATIONS. WE DONATED TO 66 DIFFERENT ORGANIZATIONS THROUGH OUR EIGHT PROGRAMS OF SERVICE COMMITTEES, OUR BUDGETED PRE IDENTIFIED ORGANIZATIONS, AND OUR COMMUNITY SERVICE COMMITTEE. WE ALSO LOAN HOME HEALTH EQUIPMENT TO LOCAL RESIDENTS FREE OF CHARGE. THIS INCLUDES WHEEL CHAIRS, WALKERS, TOILET SEATS EXTENTIONS, CRUTCHES, HOSPITAL BEDS AND OTHER NEEDED EQUIPMENT.

WE SPONSOR A DRESS YOU FOR SUCCESS PROGRAM. WE OUTFIT REFERRED CLIENTS WHO ARE LOW INCOME OR UNEMPLOYED WITH BUSINESS ATTIRE FOR JOB INTERVIEWS. WE ALSO HELP THEM SELECT OUTFITS SO THAT THEY CAN GO TO WORK WHEN NEWLY HIRED. ALL ITEMS ARE GIVEN WITHOUT CHARGE.

WE HAVE A VOUCHER SYSTEM IN COORDINATION WITH OTHER ORGANIZATIONS IN ANACORTES. VOUCHERS ARE FOR ITEMS IN OUR THRIFT STORE AND ARE ISSUED TO DESERVING APPLICANTS THROUGH OUR LOCAL SALVATION ARMY, RED CROSS, AND ST. VINCENT DE PAUL. WE ALSO RECEIVE VOUCHERS FROM OUR LOCAL SCHOOLS AND CHURCHES. WE PROVIDE BASIC ITEMS TO INDIVIDUALS FREE OF CHARGE TO THE ORGANIZATION ISSUING THE VOUCHER.

WE ALSO SUPPLY ITEMS FOR SCHOOL BOOK DRIVES, FOR BACK TO SCHOOL SUPPLIES, AND TO THE LOCAL WOMEN'S SHELTER ON AN AS NEEDED BASIS.
