TAPS NEW NATIONAL HEADQUARTERS OPENED IN JANUARY, 2013 AND FOR THE FIRST TIME HAS COMFORTABLE FACILITIES TO WELCOME LOCAL AND VISITING MILITARY FAMILIES, ESPECIALLY THOSE VISITING LOVED ONES AT ARLINGTON NATIONAL CEMETERY, AND HOST "TAPS CARE GROUPS" ON SITE FOR FAMILIES TO GRIEVE WITH OTHERS.
