GANA-A' YOO FOUNDATION IS WORKING TO INCREASE ITS PUBLIC SUPPORT PERCENTAGE. THUS FAR FOR THE 2013 TAX YEAR, IT HAS INCREASED ITS FUND-RAISING EVENTS TO INCLUDE TWO FUND-RAISERS AND A CHARITY WALK. THE FOUNDATION IS ALSO INVOLVED IN THE ALASKA PERMANENT FUND DIVIDEND PICK-CLICK-GIVE PROGRAM . THE FOUNDATION HAS ALSO RECEIVED A SIGNIFICANT CONTRIBUTION FROM GCI IN THE 2013 TAX YEAR.
