Walk Thru the Bible's resources transcend geographic, economic, and cultural boundaries. Formats include television, radio, live events, workbooks, video series, books, small group curricula and devotionals. Through our strong global network, our live events are taught in more than 45 languages by more than 25,000 trained instructors in more than 100 countries. Our live events and regular biblical resources help transform lives and nurture, develop and strengthen spiritually mature Christians. Our live events include Bible Surveys Live Events-Walk Thru the Old Testament-Walk Thru the New Testament-OT Live (for students)-NT Live (for students)-Kids in the Book Old Testament-Kids in the Book New TestamentLeadership and Teacher Training Live Events-Solving the People Puzzle-The 7 Laws of the Learner-Teaching With StyleMarriage and Family Live Events-Biblical Portrait of Marriage-Understanding the Love of Your Life-Raise Up a ChildWalk Thru the Bible conducts live events at churches, Christian schools, universities, seminaries, youth and adult camps and retreat centers, military bases, and teacher conferences. Known for innovative methods and high-quality resources, we serve the whole body of Christ across denominational, cultural, and national lines. We partner with the local church worldwide to fulfill its mission, communicating the truths of God's Word in a way that makes the Bible readily accessible to anyone. Through our strong global network, we are strategically positioned to address the church's greatest need: developing mature, committed, and spiritually reproducing believers. Our live events and small-group curricula are taught in more than 45 languages by more than 25,000 trained instructors in more than 100 countries. More than 100 million devotionals have been packaged into daily magazines, books, and other publications that reach over five million people each year. For Fiscal Year 2013, Walk Thru the Bible produced seven (7) new resources in fiscal year 2013 which included Bibles, Bible overview tools, devotionals, small group video studies, and group discussion study guides. Crucible video series, Crucible book, Great Rescue Bible, OT39 Coloring Book, OT39 Slideshow, OT39 Flashcards, and World Religions. Most of these new resources are in circulation worldwide and have been translated into several languages. Walk Thru the Bible sold 14,275 which includes Bibles, books, devotional books, small group video studies, workbooks, discussion guides, and Bible teaching tools.
