The NMCADV provides help and information to programs in partnership with the National Center on Domestic Violence, Trauma and Mental Health (NCDVTMH) to create trauma-informed organizations which deal effectively with issues of mental health, substance abuse, children and organizational development from a domestic violence, trauma-informed perspective. Currently, the NMCADV is exploring evidence-based models of intervention with child victims.

Because of the rural nature of most of New Mexico, many domestic violence programs lack access to innovative training, information, and assistance. To increase access to training statewide, in even remote areas, the NMCADV recruited and trained a group of Associate Trainers who provide training in locations all across New Mexico. The NMCADV revised and enhanced training to include a large online component and a specific skills development piece. To further increase access to training and support for domestic violence programs, the NMCADV expends a portion of its annual budget to facilitate travel for training.
